### - LEGAL -

- **CIVIL SUITS, CRIMINAL ACTIONS AND ADMINISTRATIVE HEARINGS** — PBA provides an attorney if you are named as a defendant in any civil, criminal or administrative action arising out of the performance of your duties as a sworn officer, including shootings, custodial deaths, or accidents in which someone is seriously injured.



Know Your Rights

- **DISCIPLINARY AND GRIEVANCE REPRESENTATION** — PBA provides full-time trained representatives, in-house attorneys and attorneys throughout the state to handle your work-related disciplinary investigations, grievance meetings, civil service hearings, disciplinary appeals, and CJSTC cases.

### - SERVICES -

- **LEGISLATIVE REPRESENTATION** — PBA maintains a professional team of lobbyists who are constantly working to ensure that your rights and needs are represented before the Florida Legislature.

- **PBA HEART FUND** — This charitable arm was established as an additional benefit to members to provide certain death or disability benefits to the member, spouse or dependent children when the member is killed or permanently and seriously disabled in-line-of-duty.

## FLORIDA PBA CRITICAL INCIDENTS REQUIRING AN ATTORNEY: WHAT TO DO!

- Stay Calm
- Call PBA at 1.800.733.3722
- Ask to speak with a PBA attorney

Do not talk to a Criminal or Internal Investigator until you have consulted with a PBA attorney or duty officer. If you are ordered to, request that you be permitted to consult with the PBA first.

### Guidelines for your Response to an Administrative/ Criminal Interrogation/Internal Review Statement

If you are directed to appear before an internal investigator (or any department official desiring to interrogate you), use the following checklist:

- Ask:**
- For a PBA representative to be present or reasonable time to consult one.
  - For a specific statement of charges.
  - For the identity of the complainant.
  - Whether you are the subject or a witness.
  - For a copy of all witness statements—written, video or audio.

- Do:**
- Stay calm.
  - Review your rights as spelled out in your PBA contract and F.S. 112.532 (Law Enforcement Officers' Bill of Rights).
  - Insist that you be given a reasonable amount of time for proper preparation before the interview is conducted.
  - Answer questions **fully and honestly**, but don't volunteer information.
  - Reply, "I do not remember," "I am not sure," or "I need to check my notes, report," where such answer is the truth and is appropriate (do not guess).

- Do**
- Lie.
- Not:**
- Volunteer unrequested information.
  - Submit to a polygraph examination or voice stress analysis.
  - Waive your constitutional rights to remain silent if possible criminal matters are discussed.
  - Answer any questions if they read you your **Miranda Rights** until you consult a PBA attorney.

**REMEMBER:** There are PBA representatives at most work locations. Learn who they are and how to contact them. For emergencies involving attorney call-outs, call the PBA Office at 1-800-733-3722, 24/7.

### Miranda Rights

You have the right to remain silent and refuse to answer questions. *Do you understand?*

Anything you do say may be used against you in a court of law. *Do you understand?*

You have the right to consult an attorney before speaking to the police and to have an attorney present during questioning now or in the future. *Do you understand?*

If you cannot afford an attorney, one will be appointed for you before any questioning if you wish. *Do you understand?*

If you decide to answer questions now without an attorney present you will still have the right to stop answering at any time until you talk to an attorney. *Do you understand?*

Knowing and understanding your rights as I have explained them to you, *are you willing to answer my questions without an attorney present?*
